

Cancelations and Returns Policy

REQUIREMENTS OF INFORMATION

In order to be able to process payments for the services acquired on this website, it is required by the user, who provides, at the time of purchase, a credit card. During the process to complete this payment, the user must provide the credit card number, expiration date, name and CVV2 code, as it appears on it. Additional information could include; but not exhaustively the billing address of the credit card (billing address), a valid email address and telephone number of the buyer, and the exemption from the sales tax, when applicable.

CONFIRMATION OF THE CREDIT CARD

During the purchase process and once the requested fields have been requested and filled out, the platform will connect with the company designated to process the payment for the services purchased. This connection will be used using the current security protocols. In case the transaction is positive, that is, accepted by the payment processor, it will send a confirmation or authorization number of the transaction. This number will be included in the document where the services acquired by the user are established.

STORAGE OF CREDIT CARD INFORMATION

The aforementioned fields and information to be able to complete the transaction WILL NOT BE STORED on our servers, only the four (4) last numbers of the card, as well as the confirmation or authorization number of the transaction will be saved for reference purposes.

DELIVERY OF SERVICES

Once the confirmation of payment has been received by the designated company, the corresponding documents certifying the acquisition of the contracted services will be issued. The delivery of services that are remunerated with payments by credit card will be subject to the receipt of confirmation of the total payment in the sole discretion of **WE ASSIST CORP**.
